DESCRIPTION

Stretch cotton shorts made from special Amalytton® material, which excels in increased strength and smooth, fine surface. You will appreciate the reduced weight due to the pleasant sensation when wearing. Durable and four-way elastic Tabiflex® is used on exposed areas. The shorts are equipped with an elastic waistband collar along with a hidden back double loop for comfortable belt placement, inner anti-slip tape, D-ring for carabiner, 2 hand pockets, 1 front zip pocket, 1 front utility pocket with a wide loop, a multifunctional pocket for folding meter, screwdriver, and breakaway knife with wide loops on the right leg, a large double pocket covered with a snap flap on the left leg, triple stitching in stressed areas. The back part articulates the saddle, 2 pockets, the right back pocket is covered with a snap flap. Dynamic reflective tapes and hi-vis accessories ensure increased user visibility.
